#### **DOG LICENSES**

Dog licenses will be sold at tax collection or mail the current vaccination papers along with license fee to the treasurer and license will be return via mail within 5 business days. According to Wisconsin statues all dogs over 5 months old must be licensed. Fees for spayed or neutered are as follows: \$3.30 and if not, the license is \$8.30. Kennel licenses are \$36.00

### **Permits**

### **Abandoned Wells**

- 1. Under what circumstances should I consider abandoning my existing well and drilling a new one? If your well fails to produce safe water after two chlorinations or if it fails to pass inspection, you should consider properly abandoning your well and drilling a new one. This is especially true if E. coli bacteria were ever detected in your water samples.
  - 2. How do I properly abandon my old well? Proper abandonment requires that the entire well be filled from the bottom to the ground surface with bentonite or cement. It is recommended that a licensed well driller or pump installer be hired to do this work. For more information on well abandonment, please read the DNR brochure titled "Answers to Your Questions on Well Abandonment".
  - 3. I have an old, unused well on my property. What must I do to properly abandon it? Why? Insure that any old, unused wells located on your property or your neighbor's properties have been properly abandoned. These wells are an open conduit to the groundwater supply. If poorly sealed, an unused well may allow surface contamination to drain directly to the limestone aquifer. These old, unused wells may be a safety issue.
  - 4. Where can I get information about proper well abandonment? Proper abandonment requires that the entire well be filled from the bottom to the ground surface with bentonite or cement. It is recommended that a licensed well driller or pump installer be hired to do the work. For more information on well abandonment, contact the Brown County Land Conservation Department 391-4620 or the DNR.
  - 5. **Can I get financial assistance to properly abandon a well on my property?** Cost share funding may be available for well abandonment. You should contact the

Brown County Land Conservation Department, Green Bay (920-391-4620) to obtain a cost share application and for more information on this well abandonment program. For agricultural producers, well abandonment funding may also be available through the USDA Natural Resources Conservation Service. Contact Jim Hunt, NRCS, Green Bay (920-884-3910).
