- **Ordinances:** Town lawyer advised the town to drop charges against Allan Pagel as he is deceased. However, if burning continues, the board will served citation to the propert owner.
- Jim Osterloh called the WTA for dumping mud in ditches and there is not formal ordinance, however, snow plowing ordinance reads that any materials is in violation.
- Building permit violations If building starts without a permit, fee will double. Jim Osterloh will speak with the town attorney.
- If a building permit is nearing expirations, the land owner will contact the board for an extension. Will review on case by case situation
- Jim Osterloh will visit the Sanitago property to see if abandoned cars were removed.

  - o Pulverize the existing asphalt pavement.
  - o Fine grade, water and compact the pulverized base.
  - o Construct a two course 3" compacted average depth asphalt pavement
  - o Install and compact a 2' wide crushed aggregate base course shoulder
