#### **DOG ISSUE:**

- Bid awarded to Scott Construction for chip sealing, Motion made by Kevin Taicher and seconded by Mike Goral. Motion Carried

- Culvert bids were opens for culvert work on Buyarski Road. Bids received from Jensen Excavating (\$16,500), Vandenbergh Excavating (\$10,750). Bid awarded to VandenBergh Excavating. Motion made by Mike Goral and seconded by Kevin Taicher. Motion Carried. Bids did not include the culverts (2 metal and 4 plastic) or no stone. Culvert will be done in 3 days, end of June.
- Road Damage on Allen Road was caused by an accident. Town will charge Eric Jensen, 4 hours labor for road repair, a pole and sign. Clerk will send invoice to Mr. Jensen.

#### TOWN OF MONTPELIER B/K AGREEMENT:

• Montipelier requested to amend the agreement between Eaton and Montipelier regarding the snow plowing of B/K Line Road. Montipelier proposed they would plow the section between HE Townline and JJ Road and Eaton would plow the section between Pine Grove and Shefchik Road. Eaton will response with the proposed, Eaton will cut the grass on BK Townline and Montipelier will snow plow, no extra fees.. Clerk Dawn Konop will draft the proposal and send to Scott Jahnke, Montipelier Town Chairman. Will bring back to the July Agenda.
