**MINUTES:** Motion to accept town board minutes from March 7, 2022. Motion was made by Mike Goral, second by Kevin Taicher. Motion carried.

**OUR SAVIOR OF EATON CEMETARY:** located on Hwy 29, west of Phillips Road. The cemetery has been abandoned, and the town of Eaton will assumed responsibility for the upkeep. Chairman Jim Osterloh will contact Grunt Landscaping to cut lawn 6 times a year. Motion by Jim Osterloh and seconded by Mike Goral to table to May meeting. Motion carried.
